Core Asset Classes

BlockHouse Fund invests primarily in:

- U.S. Equities: High-conviction positions in liquid large-cap and sector leaders.
- Index ETFs: Exposure to S&P 500, Nasdaq, Russell 2000, and sector-specific ETFs.
- Commodities: Strategic positions in energy, metals, and agriculture.
- Options: Use of calls, puts, and spreads for hedging, leverage, and income.

Tactical Allocation Approach

- Market-neutral overlays in high-volatility regimes.
- Event-driven trades based on earnings, policy changes, and macroeconomic catalysts.
- Options-based tail risk hedging.
- Dynamic rebalancing to maintain target risk exposure.

Risk Management

Risk is monitored on both a micro (position level) and macro (portfolio level) basis, including:

- Value-at-Risk (VaR) and stress testing
- Volatility targeting
- Liquidity analysis and drawdown controls
